However, this activity is NOT ALLOWED in the locations enforced by EMCO

Entry from Red Zone at sea and air entry points for Sign On must submit the negative COVID-19 test result confirmation three (3) days from the date of entry and must undergo 14 days mandatory quarantine before Sign On. • Water transport services for RoRo Ferries, Express Ferries and Speedboats are ALLOWED to operate with limited capacity based on physical distancing in the transportation from 6.00 am until 10.00 pm. • Water taxi transport services, passenger boat (bot penambang) and pilotage (pemaliman) are ALLOWED to operate from to operate from 6.00 am to 10.00 pm except for Sign Off activities. • Transportation service for Sign Off activities is only ALLOWED to operate from 6.00 am to 6.00 pm only in compliance with current rules and SOPs in force. • Activities related to NCS Ships (Kumpit) to Labuan for transshipment purposes are NOT ALLOWED. • For ships coming from Sabah, Sarawak and outside the waters of WP Labuan into WP Labuan for a period of 14 days, crews performing Sign Off must undergo mandatory quarantine for 14 days.

Sports and Recreational Activities	<ul style="list-style-type: none"> • Sports and recreational activities without physical contact (indoor and outdoor) are allowed. Activities carried out individually must not exceed 10 people by ensuring social distancing (static activities: 1-3 meters and dynamic activities: 3-5 meters) such as walking, jogging, cycling, self-training aerobics, hiking, fishing etc. are ALLOWED with compliance to the SOPs of the Sports & Recreational Sectors. • Permission to operate and use sports facilities by the public is RESTRICTED to training activities that do not involve physical contact and comply with the Sports & Recreational SOPs. Consumer capacity for each premise involved should not exceed 50% of the total capacity of the respective premise. Entrepreneurs and sports operators must schedule the training sessions accordingly if there are many participants by limiting the number of users at a time. • Existing centralised training programs being implemented by the National Sports Council and respective State Level Sports Councils can be continued on a "Quarantine Based Approach" as implemented in MSN Complex at Bukit Jalil and Keramat, Badminton Academy Malaysia, Bukit Kiara, Paralympic Sports Center of Excellence, Kg. Pandan, Sunway Megalanes and Velodrome, Nilai.
